## AMHA Director Report - Sheryl

The 2025 Annual Meeting is just around the corner – November 13 - 15, at the Double Tree by Hilton in Houston, Texas. We encourage all to attend this year's meeting and to vote on the proposals and next year's officers.

The Board has been challenged with some tough decisions this year. The Regional Shows have not been profitable, and with the cost of facilities and awards increasing next year, some decisions need to be made on how we handle them. This will be discussed and decided at the Annual Meeting in just a few short weeks.

Rising costs, building maintenance, and reduced income have all contributed to a tight financial year. The Finance Committee is working closely with the Board on recommendations for "tightening our belt" in 2026. Many solid and workable solutions are going to be presented and voted on at the Annual Meeting. At this time we are financially stable, but there is no "fluff" in our budget.

AMHA will be sending out a survey to all members in a few days. Since holding a virtual meeting

at this time is too costly, we are distributing the survey to gather your opinions on the proposals being voted on at the annual meeting and, most importantly, to hear your comments, ideas, and thoughts on each proposal. These results, along with each of the comments, will be shared with the assembly at the meeting so that everyone attending to vote can hear the opinions of our members.

Please remember to renew your membership for 2025, send in your stallion service reports, nominate your futurity horses and finish up your foal registrations. Lots to do at the end of the year.

Discussion regarding the Western Regional show moving back to Oregon:

The last couple of years the area costs were donated by Aimee Davis. The membership would like to see it moved back to the Oregon Horse Center. Prairie Arena Cost is \$750 per day, and can hold 90 stalls inside. Silverado Arena costs \$1,175 per day with the warmup. Normally set up as a 3 day show but could be cut down to a 2 day show to save money. The plan is to have an answer by the end of the annual meeting.

Lisa Brostad offered to donate \$1000 towards Regionals, Joanne offered the possibility of a judge being paid for. Other pledge donations offered: Kelly and Cherie Jensen \$200, Howard stables \$100, Becky Nicol \$500, Leslie White \$100, Sharon Hardt \$100, Kristie Bingaman \$200, Tammy Osgood \$250, Matt Davern \$100, Helen Halderman \$100, Ronda Figel \$100, Kelly Kelvin \$100, Kelly Egilske \$100, Danna Ash \$100.

Show committee Report

We will have 3 shows this year

Rinda will manage 2 shows and Sharon Hardt will manage the third

Western Washington May 23-25 in Ridgefield will be a 3 day show with 2 days of A classes and 1 day of R classes. It will be sanctioned by both registries. We have a class list made up from Norcal and Arizona shows that regularly offer R shows. We have not made changes to the A class list.

Summer Classic June 20 & 21 In Eugene in the prairie arena, Sharon will be the manager. Howard Stables and Casino Gold will be the coordinators.

Emerald Valley July 25 & 26 in the Prairie arena. Managed by Rinda, Joanne Ross and Tom Soto coordinators.

Working on finding someone to fill the gate position.

Recommendation from the Directors to pay the Gate person \$400 for the weekend - No discussion - Membership passes

Recommendation from the Directors to raise the Announcer pay to \$400 for the Weekend - No discussion- Membership passes

Recommendation from the DIrectors to pay Sharon as Show Manager \$1000 for the show - No discussion- Membership passes

Recommendation from the directors to pay a Ring Steward for the Summer Classic show \$400 for the weekend - No discussion - Membership passes

Recommendation from the directors to pay \$250/day plus mileage and RV parking for the AMHR Steward - Membership passes

The Judges fee at a flat rate of \$1400 is no longer working. Discussion about what the judges need to pay in expenses for airfare/mileage, lodging, and judges fees. We generally buy their lunches.

Jessie - feels that they need to make ~\$1000 after expenses. The majority of the Judges are charging OT fees past 8 hours

Kathy - some of the judges have mileage and hotel dividends We have in the past had a rate for local judges vs non.

Recommendation to increase the flat rate from \$1400 to \$1700 as a starting point.

Sharon Hardt moves to raise the fee to \$1700 for 2 or 3 day shows. Matt Seconded Discussion: we would need to increase for an additional day. Additional expenses to add a day include hotel night and day fee. The R show would count as a second show during the same weekend as the A show. Recommend wording change to per weekend vs per show.

Addendum to the motion: change 2 or 3 day shows to per weekend. Motion passes Club trailer Show coordinators will be responsible to get the club trailer to and from shows. Seemed to work well this year.

Leslie White -The youth committee did not meet and did not get going this year, we need help at the show from people who are not busy showing at the shows. Sheryl suggested that we change the direction of the youth committee to youth development and have events outside of horse shows. Opportunities for the youth to get to know each other, encourage more youth participation. Katie Gauthier will head a youth development program.

**MEMBERSHIP** 

Membership eligibility in the Northwest Miniature Horse Club (NWMHC) shall be as stated in the current club Bylaws under Article II – MEMBERS; Section 201- Eligibility. See the Bylaws for eligibility and the application process to become a member of NWMHC. Annual dues are as follows:

1. FAMILY MEMBERSHIP DUES: \$45.00 for up to two (2) adults, living at the same permanent address, and includes their dependent children and/or grandchildren (see Youth as defined by AMHA). Name and date of birth of all dependent children/grandchildren must be provided on the application.

Jessie Spoke with Rob Crater - would be more beneficial to join forces with the existing R club Joanne - feels that the conversation of changing is premature, we need to trial adding R classes at Western Washington as planned and see

Joanne made a motion for 2026 2 shows are required to qualify for year end awards. Charrisa Seconded - Motion passes.

State Fair Points for year end awards - Matt Davern

Has talked with Ron to add a fee to entries so that a portion of profits support the NWMHC.

Ron is retiring, Matt is working with Ron to find a manager that will be able to run the AMHA program and moving the date to a weekend. There are no final decisions about the horse shows at the state fair.

AMHA passed double points awarded at fairs for honor roll.
