30 minute **LUNCH BREAK** to follow clinics.

**SCHOOLING SHOW** will start at 12:00pm.

You may cross enter between the regular halter and stock type halter classes. You may cross enter between the driving classes (classic, country, single, roadster).

More than 1 person may show the same horse in the same showmanship, hunter, halter obstacles, and obstacle driving classes. You will need a separate entry form and number for each horse/handler team.

## Schooling Show ENTRY FORM – Pre-Entries Appreciated

Every entry at this show shall constitute an agreement that the person making it shall be subject to the rules of the show, and that every horse and handler is eligible as entered, and that the owner, handler, and any of their agents or representatives agree to hold the Show Management, Show Officials, Show Facility, Employees, Agents, and the Northwest Miniature Horse Club harmless for any injury or loss suffered during or in connection with the show. The Equine Inherent Risk Laws of Oregon shall be in effect. By signing this entry, I indicate that I have read, understand, and agree to be bound by this agreement, the rules of the show and hereby accept responsibility under these rules for the participation of any minor under my supervision.
